voting outcome

1. Formatting and grammatical changes that have no material impact on the meaning or intent of the bylaws. YES: 86\%; NO: $14 \% \rightarrow$ PASSED
2. SECTION 5.3. HOLDING OFFICE requiring certified members to be ACTIVE to be qualified to hold office or be a member of the Board of Directors. YES: $74 \%$; NO: $26 \% \rightarrow$ PASSED
3. SECTION 9.2. PART 1 - COMPOSITION OF THE BOARD OF DIRECTORS changing the board size from no less than 7 and no more than 12 members, to 9 members.
YES: 55\%; NO: 45\% $\rightarrow$ DID NOT PASS
4. SECTION 9.2. PART 2 - COMPOSITION OF THE BOARD OF DIRECTORS changing the board seats from all elected to 6 elected and 3 appointed by the board. YES: $26 \%$; NO: $74 \% \rightarrow$ DID NOT PASS
5. SECTION 9.2. PART 3-COMPOSITION OF THE BOARD OF DIRECTORS clarifying that appointees do not have to be members of the organization. YES: $18 \%$; NO: $82 \% \rightarrow$ DID NOT PASS
6. SECTION 9.3. TERM OF OFFICE which clarifies the 3-year election rotation to account for 2 elected directors and 1 appointed individual every year. YES: $33 \%$; NO: $67 \% \rightarrow$ DID NOT PASS
7. SECTION 9.4. NOMINATION AND ELECTION OF DIRECTORS which states that no more than 6 elected members of the Board shall serve the General Membership of the Corporation at any time and clarifies that two directors will be elected each year by the membership.
YES: 37\%; NO: 63\% $\rightarrow$ DID NOT PASS
8. SECTION 9.5. APPOINTMENT OF DIRECTORS which restates that no more than 3 appointed members of the Board shall serve on the Board at any one time and no more than 1 Director shall be appointed for a three-year term each year by the Board with a super-majority (2/3rds) vote. YES: 32\%; NO: 68\% $\rightarrow$ DID NOT PASS
9. SECTION 9.8. FILLING VACANCIES which raises the voting bar for the board to appoint directors from a simple majority to a super majority (2/3rds) vote. YES: 50\%; NO: 50\% $\rightarrow$ DID NOT PASS
10. SECTION 9.10. REMOVAL OF DIRECTOR which raises the voting bar to remove a sitting director from a super majority ( $2 / 3$ rds vote) to a $3 / 4$ th vote. YES: $50 \%$; NO: $50 \% \rightarrow$ DID NOT PASS
